South Sulawesi Province's ranking in Pekan Olahraga Nasional in West Java XIX 2016 with a Gold Medal Target of 50 for the target of entering the top 5 but it failed again because it only got 12th place with 12 Gold, 23 Silver 28 Bronze medals totaling 63 medals, and the South Sulawesi Contingent in the National Sports Competition of the year 2021 in Papua Province was ranked 11th only up 1 place from before with a total of 37 medals, with details of 11 gold medals, 13 silver medals and 13 bronze medals, of course this is a pride for the Governor of South Sulawesi but this is a big problem because it has not been able to reach the top 5 and even enter the top 10 cannot, this is a big question why South Sulawesi has not been able to provide encouraging results even though it has received funding from the south Sulawesi provincial government which is so fantastic.

Program The implementation of a sustainable integrated sports coaching center needs to be implemented systematically, integrated, tiered and sustainable. The program is intended as the direction of the international achievement sports coaching policy through the implementation of an effective and efficient program with a rational rational rationale. In general, South Sulawesi's sports achievements have not shown encouraging results, and tend to lag behind other regions such as DKI Jakarta, West Java, East Java, Central Java, East Kalimantan, Riau and Papua.

The slump in sports achievements at the national level is thought to be influenced by factors of the program implementation process that occurs. ### **METHODS**



# **RESULTS AND DISCUSSION**


# **Implementation of the Sustainable Integrated Sports Development Center (P2OTB) Program in South Sulawesi**
