Abstract. Women with special needs in the societal perspective of entrepreneurs have the same obligations and obligations to be empowered for the progress of a nation. This was confirmed by the United Nations Declaration on "Human Rights Equality 'and the Figh of Strengthening Persons with Disabilities" in Indonesia. Therefore, efforts to provide training and entrepreneurship apprenticeship activities to them by the family, school or campus, the business world, the government, and the community are very urgent. The training and entrepreneurship apprenticeship efforts aim to make them independent in entrepreneurial activities, so that they can contribute to improving the quality of life of the family economy in particular, and the economic quality of life of the people, nation, and country in general in the Covid-19 era. There are various sectors of entrepreneurship that can be carried out by women with special needs, namely in the procurement of goods and services in the family, school or campus, and in the community. Through their participation in the goods and services business, they are expected to contribute in improving the economic quality of their families in the Covid-19 era.

#### **INTRODUCTION**

Fourteen centuries ago before Muhammad SAW taught and educated ignorant Arabs with Islamic teaching and education, the fate of Arab women in the age of ignorance which is also called the era of ignorance was very alarming, because women in the ignorance era, they do not have humanistic values, whose role is only as a sexual appetite for men. Even very sad in the days of ignorance, women can be a medium of debt repayment for husbands who lose in gambling matches, and ignorant Arab men can give up their wives to be slept with by other men or husbands.

However, after Muhammad (PBUH) began preaching Islamic teachings among the Arabs of ignorance in Mecca, by first changing the faith of the Arabs, the Jahiliah from worshiping many Gods who made themselves, then worshiping an almighty god .. On the other hand, in the field of entrepreneurship, women with special needs also have the potential to grow and develop optimally and optimally in achieving self-actualization in entrepreneurship. This, of course, is very reasonable because they follow the sunnah imitated by Sitti Khadijah the wife of the Prophet Muhammad who succeeded in entrepreneurship and became a famous businessman and became a rich man in Makkah in his day (Latif, 2020; Somad, 2019).

In order to assist the government in the field of women's empowerment, as a work program of the Ministry of Women's Empowerment, the provision of entrepreneurial social training to Indonesian women, more specifically to Indonesian women with special needs in the Covid-19 era is absolutely necessary to improve their economic standard of living (especially those affected by Covid-19 influence) in order to achieve economic independence and social life independence among themselves, and to help improve the quality of life of their affected families covid-19. The provision of entrepreneurship social training to women in the workplace or in business centers, in vocational training centers, and in the home environment that is carried out by research teams from universities with special needs can be done in the school environment, in or from community social institutions (Nurhayati, 2020).

A side from being a form of entrepreneurial social training that can be given to women with special needs, the provision of mentoring programs by businesses through "Internships" at work or at business centers, is also a solution option to empower women with special needs in adult social entrepreneurship activities. this, in order to improve the quality of economic life of their families affected by Covid-19's influence. Therefore, giving special attention and special services to women with special needs in the social-entrepreneurial field by all parties involved, is a moral obligation for us together to do so.

The related parties in question are the Ministry of Education and Culture, the Ministry of Manpower, the Ministry of Women's Empowerment, the Central Government, Regional Governments, Community Social Organizations, Community Leaders, Educators, and the Business World at the domestic level. Whereas at the international or international level, those who must give special attention and special services to the problems of education, and the social-entrepreneurship of women with special needs, are the Unesco, Unicef, ILO, and other International Organizations that care about women with special needs.



Another question that arises relating to women with special needs in a societal-entrepreneurial perspective, is what types of social-entrepreneurial activities can be trained and traded to women with special needs in training centers and apprenticeship work both in the school, work environment , and in the community? This question will be answered through the description of the study discussion on the following subject.

### The Kinds Of Societal-Entrepreneurs For Women Special Need

The types of social entrepreneurial activities that can be trained and traded to women with special needs, in an effort to improve the quality of economic life of their families affected by Covid-19, include:

- 1. Acting as a retailer and retailer based shop for daily needs in the family environment, school environment, and in the community environment that is trained to be traded, and facilitated by the family, school, and community.
- 2. Acting as a painter, who can be trained and traded and facilitated in the environment of a painter who has succeeded in selling the services of his paintings in the midst of the community.
- 3. Acting as a dancer, who can be trained and traded, and facilitated by the family, school or campus, and the community.
- 4. Acting as a singer or musician who can be trained and traded and facilitated in the environment of a singer who has succeeded in selling the services of singing and composing songs in the midst of the community.
- 5. Acting as a drummer in a family, school or campus environment, and in a community environment that is trained, traded, and facilitated by the family, school, and community.

  6. Acting as a bass player, who can be trained and traded and facilitated in the family, school or campus, and in the community.
- 6. Acting as a melody player, which can be trained and traded, and facilitated by the family, school or campus, and the community.
- 7. Acting as a Key Board player who can be trained and traded and facilitated in the family, school or campus environment and the community.
- 8. Acting as a tailor or tailor who can be trained and traded and facilitated in the family, school or campus and community environment. Suturing business that is reaping the market today is a sewing mask business, and various personal protective equipment (PPE) to be worn by general public. medical personnel, doctors, and other health workers, as well as for

Serving as a catering businessman who can be trained and traded and facilitated in the family, school or campus and community environment, especially in the catering industry that has succeeded in yakat For example, in Makassar, the famous and famous ones are Balqis Catering, Seruni Catering, and others.
- 10. Serving as a food stall seller, which can be trained to be traded and facilitated in a family, school or campus environment (especially at the Tataboga Department in the Family Welfare Education Study Program at the Faculty of Engineering,



Makassar State University), and the community environment, especially in the restaurant industry environment what has been successful in the community, for example in Makassar which is well known and famous is the Wong Solo restaurant, the Nyoto restaurant, and others.

- 11. Acting as a chef in a catering businessman who can be trained and traded and facilitated in a family, school or campus environment (especially at the Tataboga Department in the Family Welfare Education Study Program at the Faculty of Engineering, Makassar State University), and in the community, especially in the environment Catering industries that have been successful in the community, for example in Makassar which are well known and famous are Balqis Catering, Seruni Catering, and others.
- 12. Acting as a coffee shop entrepreneur or "Warkop" which is a trend nowadays, which can be trained and traded and facilitated in the family, school or campus and community environment, especially in the coffee shop or coffee shop industry that has been successful in the community, for example in Makassar, which is well known and famous is Latansa coffee shop, Boulevard coffee shop or coffee shop, etc.

Playing as a computer operator in various government and private institutions that can be trained and traded and facilitated in the family, school or campus environment and community environment, especially in computer typing and computer-based printing environments, and computer education and training centers, for example in Makassar, which is well known
- 14. Serving as a Cleaning Service in various government and private institutions that can be trained and traded and facilitated in the family, school or campus environment and community environment, as well as cleaning service personnel who have experience working in government and private offices in Makassar City, Makassar, which can be trained and traded and facilitated in the family, school or campus environment (especially at the Department of Entrepreneurship at
- 15. Serving as a salesperson in various retail stores and malls in the City area the public, especially in the mall environment and retail shops that are mushrooming in Makassar City today

Acting as a tour guide in various tourist attractions in the Makassar City area in particular and in South Sulawesi in particular, which can be trained and traded and facilitated in the environment family, school or family s (especially in the Department of Entrepreneurship at the Faculty of Economics, Makassar State University and Makassar City Tourism Polytechnic and in the community environment, especially in tourist areas in Makassar City and in South Sulawesi.

Acting as a sign language guide in various television stations, both government and private, which can be trained and traded and facilitated in the family, school or campus environment (especially in the Department of Special Education at the Faculty of Education (FIP) Makassar State University and the Communication

This has been confirmed by the United Nations Declaration on "Equality" or the equal rights and obligations of humanity or "Human Rights Declaration" on this earth. In addition, the Center for Research and Development of Gender Studies (P3KG) of Hasanuddin University in collaboration with the Swadaya Mitra Bangsa Foundation (2019) has conducted studies, research and development of Gender, including studies on persons with disabilities, which also includes studies on gender or women with disabilities. specifically in social and entrepreneurial perspectives.
